# Appearance Design Solicitation Document for TWG 2025 Chengdu Torch

The World Games 2025 Chengdu (hereinafter referred to as "TWG 2025 Chengdu") will be held in Chengdu from 7 to 17 August 2025. TWG 2025 Chengdu Torch, as a key element of TWG, will be a major carrier that spreads the ideas of TWG and showcases China's fusion of culture and technology. The Executive Committee of The World Games 2025 Chengdu (hereinafter referred to as the "Chengdu ExCo") cordially invites natural persons, legal persons, and other organizations interested in participating in the design of TWG 2025 Chengdu Torch to actively take part in the Solicitation, contributing their wisdom and strength to TWG 2025 Chengdu.

#### **Part I Instructions to Applicant**

1.1 General

Chengdu ExCo welcomes and appreciates all qualified applicants participating in the Solicitation. All applicants should submit the application document as required on time. Chengdu ExCo expects to select the appearance design and related extended designs of TWG 2025 Chengdu Torch, and will organize and complete the Solicitation as scheduled.

1.2 Basic Rules for Applicant

The basic rules that the applicants must follow include but not limited to:

(1) Applicants should comply with the applicable laws, regulations, and normative documents, including but not limited to the applicable provisions of Chinese laws, regulations, rules, and other normative statutory documents, laws and regulations of other countries/regions that the applicant should follow (if applicable), and applicable rules stipulated by the International World Games Association (IWGA) and Chengdu ExCo.

(2) Applicants should bear all costs incurred from participating in the Solicitation. Neither IWGA nor Chengdu ExCo will be liable for such costs.

(3) Applicants acknowledge and agree that IWGA and Chengdu ExCo are entitled to use the application documents submitted by applicants free of charge for the purpose of soliciting and evaluating the design schemes of TWG 2025 Chengdu Torch. Chengdu ExCo will not disclose these documents to any third party other than IWGA, Chengdu ExCo itself, and their designated working teams.

(4) Applicants should comply with other requirements herein.

#### Part II Qualifications of Applicant

All natural persons, legal persons, and unincorporated organizations interested in the appearance design of TWG 2025 Chengdu Torch and willing to comply with all solicitation requirements may participate in the Solicitation independently or in collaboration.

#### Part III Composition of Application Document

3.1 Composition of Application Document

Each application document should consist of the following two complete and inseparable parts: Part I, written documents and supporting documents signed and submitted by the applicants for participating in the Solicitation (hereinafter collectively referred to as the "Qualification Documents and Legal Documents"); Part II, design scheme. Applicants should submit the application documents on time and in accordance with the requirements in the Solicitation Document. The application document not complying with Articles 3.2 and 3.3, and other requirements in the Solicitation Document (including but not limited to missing, omitted, or false content) may be considered invalid due to the applicant's failure to meet the requirements. Chengdu ExCo is entitled to reject such application document or disqualify the applicant from the Solicitation. Chengdu ExCo is entitled but not obligated to request supplement from applicants for follow-up work and procedures.

3.2 Qualification Documents and Legal Documents

The Qualification Documents and Legal Documents that applicants must sign and submit for the Solicitation consist of the followings:

(1) Letter of Commitment (see Appendix 1);

(2) *Letter of Authorization* (see Appendix 2, to be signed and submitted by legal persons or unincorporated organizations only);

(3) Application Forms (see Appendix 3);

(4) Identity document of applicants: Chinese natural persons must submit a copy of *Resident ID Card* while non-Chinese/stateless natural persons must submit a copy of passport or other valid identity document; if the applicant has a statutory agent, a copy of the statutory agent's valid identity document should also be submitted according to the requirements stated above); legal persons or unincorporated organizations should submit copies of their business licenses,

certificates of organization code, if any, and valid identity documents of their legal representatives or persons in charge, and authorized persons, if any.

(5) Other documents required by Chengdu ExCo.

3.3 Design Scheme

The design scheme should consist of the appearance design and design description of TWG 2025 Chengdu Torch, among which:

(1) The appearance design includes appearance design renderings and three-view drawings or CMF, technical specifications and parameters (including materials and production process used). After the final scheme is determined, the applicant submitting the first-ranked design scheme should produce a torch model (without the combustor) on a scale of 1:1.

(2) The design description refers to detailed explanations of the creation basis, concept and process of the design scheme as well as breakdown of production costs.

Note: After the final scheme is determined, the applicant of the firstranked design scheme should extend the design to appearance of flame lantern, cauldron, ignition rod, safety key, torch display stand, torch base, and torch packaging box that matches the torch appearance.

#### Part IV Design Requirements

4.1 Overall Design Requirements

The appearance design of TWG 2025 Chengdu Torch should align with TWG concept and vision, and fully embody the organization concept and goal of TWG 2025 Chengdu, while balancing the international perspective with Chinese characteristics and Chengdu charm.

TWG concept and vision: "To be athlete-centered and provide a stage for self-expression and unrestricted performance".

4.2 Appearance Design Requirements

(1) Featuring a novel, aesthetically presentable style, characteristics of China and our era, and a profound understanding of ancient Shu civilization and Tianfu culture, the work should fully showcase Chengdu's unique elegance and charm, while also taking into full account subsequent industrial production of the design. The design scheme should detail the creation foundation, concept and process as well as production costs;

(2) The appearance design and its extended designs should reserve a prominent position for the logo (logo combination) of TWG 2025 Chengdu (with vector diagram of the logo attached to the Solicitation Document for download);

(3) The design scheme should ensure both use safety and good visual combusting effects when the torch is held in hand or displayed in a fixed position, in pictures or during broadcast;

(4) The design scheme can inspire a sense of holiness in torch bearers and spectators and showcase the vitality and passion of torch relay.

4.3 Technical Requirements

(1) Easy to hold and reflecting green, environment-friendly, and sustainable concepts;

(2) Encouraging the use of new materials, processes, and technologies, with an intense sense of technology, and achieving an integration of artistic design and scientific and technological innovation;

(3) Suitable for industrial production.

4.4 Other Requirements

The appearance design and its extended designs must be originals rather than previously published works or reproductions, modifications, adaptations, or deductions of any other's works and must be distinct from the torch appearance designs of major international sports events such as Olympic Games, FISU Games, and Asian Games, and from those used in large-scale domestic sports events and activities. The drawings in the application document must not contain any content that could identify the applicant.

#### Part V Submission of Application Document

Applicants must submit their application documents according to the following requirements. Failure to do so will be considered non-compliance and will directly affect the reception and evaluation of the application documents.

There is no limit to the number of designs submitted by each applicant. An applicant may submit one or more sets of application documents.

5.1 Submissions and Their Order

Each application document must consist of all documents applicable to the applicant in the following order. Documents optionally submitted by applicants should also be arrayed in the following order:

- 4 -

(1) *Letter of Commitment* (A4 printed and signed or scanned signed copy, to be submitted by all applicants);

(2) *Letter of Authorization* (A4 printed and signed or scanned signed copy, to be submitted by legal persons and unincorporated organizations only);

(3) *Application Forms* (A4 printed and signed or scanned signed copy, to be submitted by all applicants);

(4) Identity document of applicants (A4 reproduced or scanned copy, to be submitted by all applicants);

(5) Qualification documents and other documents that applicants deem necessary to submit (A4 printed, copied, or scanned copies, to be submitted by applicants at their option);

(6) Design scheme (in hard and soft copies, design drawings in JPG or TIFF format, with minimum 300dpi, text in PDF format, to be submitted by all applicants);

(7) Other documents that applicants deem necessary to submit (to be submitted by applicants at their option);

(8) Other documents required by Chengdu ExCo (if applicable).

5.2 Requirements for Packaging, Originals, and Copies of Submitted Documents

(1) Applicants should put the documents listed in Items (1)-(5) of Article 5.1 in one envelope (i.e., the "Qualification Documents and Legal Documents"), and documents listed in Items (6)-(8) of Article 5.1 in another envelope (i.e., the "Design Scheme").

(2) The Qualification Documents and Legal Documents and the Design Scheme must be enveloped and sealed, respectively, with the upper right corner of each sealed envelope marked with "Qualification Documents and Legal Documents" or "Torch Design Scheme" correspondingly, and then be put in one file bag, with the upper right corner of the bag marked with "Original".

(3) Applicants must prepare a copy in accordance with the sealing requirements for the original (the copy may be a photocopy of the original), with the upper right corner of the file bag marked with "Copy". In case of any discrepancy between the original and the copy, the original shall prevail.

(4) Applicants must package and seal the separately sealed original and copy together and submit the package according to the time and method specified in Article 5.6 below.

5.3 Completing, Signing, and Other Requirements of Application Document

(1) The original *Letter of Commitment, Letter of Authorization* and *Application Forms* should be completed using non-fading blue or black ink and signed by applicants. Should the applicant be a natural person, these documents should be signed by the natural person (statutory agent's consent is required if the natural person has no or limited capacity for civil conduct) personally (the signature should be identical to the one on the submitted identity documents and be signed in normal manner, the same below); should the applicant be a legal person or unincorporated organization, these documents should be signed by the legal representative/person in charge and authorized representative and affixed with the official seal, if any.

(2) The original Qualification Documents and Legal Documents should be signed by applicants at the signature column. Should the applicant be a natural person, the documents should be signed by the natural person (statutory agent's consent is required if the natural person has no or limited capacity for civil conduct) personally; should the applicant be a legal person or unincorporated organization, the documents should be signed by the legal representative, person in charge or authorized representative and affixed with the official seal. In case of more than one applicants for one application document, each applicant must sign as per the above requirements.

(3) Text alterations or insertions (except written modifications requested by Chengdu ExCo) should be avoid in the application documents. In case of necessary corrections, the applicant should sign to confirm such corrections (see Item (1)/(2) of Article 5.3 for signature requirements).

(4) For application documents that are selected for re-evaluation, any composed document that is formed in any other country must be notarized by a notary office in that country and then be authenticated by the Chinese embassy or consulate there, or certified according to the procedures specified in the relevant treaties entered into by and between China and that country while documents formed in Hong Kong, China, Macao, China, or Taiwan, China should also be certified according to the applicable procedures.

5.4 Language of Application Document

The application document must be prepared in either Chinese or English. Otherwise, the applicant must provide a corresponding Chinese translation and guarantee its authenticity and accuracy.

5.5 Application Document Receiving Time and Mailing Method

(1) Applicants must mail their application documents, which shall meet all requirements, to the Division of Torch Relay, Department of Media (Opening and Closing Ceremonies), Chengdu ExCo, or send them via email to the designated email address, after the start time and before the deadline for application document receiving. Chengdu ExCo is not responsible for the late delivery of the application documents.

The start time and deadline for receiving the application documents are subject to the time when the recipient receives the documents at the designated address:

In case of any change to the mailing address or other information above, Chengdu ExCo will make a timely announcement via official channels such as the official website (theworldgames2025.com). Please check such announcement regularly.

(2) The application documents delivered to Chengdu ExCo after the deadline will be rejected. All the application documents received will be evaluated since 28 September 2024 (Beijing time).

(3) If Chengdu ExCo decides to extend the deadline of application document receiving, it will publish such information on the official website at least 10 days before the new deadline. In such case, the rights and obligations of both Chengdu ExCo and the applicants will be subject to the adjusted deadline.

(4) All application documents submitted to Chengdu ExCo will not be returned.

5.6 Modification and Withdrawal of Application Document

(1) Applicants who have already submitted the application documents may modify or withdraw the documents before the deadline of application document receiving, provided that the applicants that are identical to those submitting the application documents send a written notice to Chengdu ExCo in advance, specifying the submission time and method of the application documents submitted (for submission by mailing, the sender name and tracking number must be specified), and sign on the notice according to the requirements in Item (1)/(2) of Article 5.3 for confirmation. If applicants request to modify the application documents, they should submit the modified application documents in accordance with all requirements in Articles 5.1-5.5.

(2) The modification or withdrawal notice and the modified application documents must be delivered to the recipient of the Solicitation before the deadline of application document receiving. All late notice and documents will be deemed invalid.

5.7 Under any of the following conditions, the design scheme may be considered invalid:

(1) The application document is incomplete, such as missing appearance design renderings and three-view drawing, external and internal structural drawings, technical specifications and parameters, or design description;

(2) The design scheme has any information that can be used to identify the applicant;

(3) The design may be confused with torches of other domestic or international sports events or large-scale activities;

(4) The design may infringe on any third-party rights such as copyrights, trademark rights, and design patent rights;

(5) The design is identical or similar to works published, including but not limited to personal works released on Internet platforms;

(6) The design contains any political, religious, or commercial information, including but not limited to trademarks and design patents under application or registration by the applicant;

(7) The design violates the laws and regulations of the People's Republic of China, and contradict the Olympic spirit, the Paralympics concept, or public order and good morals.

#### Part VI Solicitation Procedures and Bonus

6.1 Solicitation Procedures

Applicants may download the Solicitation Document via the official channels, such as the official website of TWG 2025 Chengdu (theworldgames2025.com), since it is released by Chengdu ExCo.

Applicants should prepare their application documents in accordance with the requirements in the Solicitation Document and ensure that the application documents are delivered to Chengdu ExCo after the start time and before the deadline of application document receiving. No application document will be returned. No application document delivered after the deadline of application document receiving will be evaluated by the Evaluation Panel of the Solicitation.

Any application document not complying with the form requirements in the Solicitation Document may be deemed invalid.

The Evaluation Panel will review all application documents that pass the formal evaluation, and select not more than 10 application documents as shortlisted schemes in the primary evaluation, and 3 shortlisted schemes as candidate schemes in re-evaluation. Chengdu ExCo will notify the applicants of the shortlisted schemes and candidate schemes by telephone or fax. The candidate schemes will be submitted to Chengdu ExCo and IWGA for final determination of the appearance design of TWG 2025 Chengdu Torch.

6.2 Bonus of Solicitation

A bonus of CNY 10,000 (pre-tax) will be awarded for each shortlisted scheme, CNY 50,000 (pre-tax) for each candidate scheme, and CNY 100,000 for the ultimately selected appearance design of TWG 2025 Chengdu Torch. The bonuses mentioned above shall not be accumulated.

If there are more than one winning applicants, they may allocate the bonus by themselves. Chengdu ExCo will not be liable for any dispute arising therefrom. After the Solicitation concludes and all qualified documents from the winning applicant are received, Chengdu ExCo will pay the bonuses (after tax withholding according to laws) to the bank account designated by the winning applicant.

#### Part VII Mandatory Legal Provisions

7.1 Governing Laws

The Solicitation is governed by the laws of the People's Republic of China.

7.2 Confidentiality and Promotion Restrictions

Whether the submitted application documents are ultimately selected, all applicants should keep their application documents submitted for the Solicitation and related documents and information confidential before the closing of TWG 2025 Chengdu, and must not disclose any of such documents or information to any third party in any manner. Applicants shall neither engage in any commercial promotion about their response to the Solicitation Document or participation in the Solicitation at any time, in any place, or in any manner, nor implicitly or explicitly indicate any association with TWG 2025 Chengdu or Chengdu ExCo.

During the Solicitation, Chengdu ExCo reserves the right to disqualify any applicant who violates the aforementioned confidentiality and promotion restrictions from participating in the Solicitation.

Chengdu ExCo is entitled to demand indemnification from the applicant for any loss suffered by Chengdu ExCo or TWG 2025 Chengdu arising from the applicant's violation of such confidentiality and promotion restrictions.

7.3 Intellectual Property Rights Regarding Candidate Schemes and Selected Scheme

(1) The applicant of a candidate scheme should sign the relevant legal documents with Chengdu ExCo according to the time and place specified in the notice sent by Chengdu ExCo within 10 days upon receipt of such notice, agree to make appropriate modifications and improvements to the application document on his/her own or by authorizing Chengdu ExCo to do so if necessary, and agree on issues such as the relevant intellectual property rights in the application document. If the applicant explicitly refuses to sign the above documents, it will be deemed that the applicant has automatically given up his/her candidacy. In such case, Chengdu ExCo should no longer consider the application document of such applicant as a candidate scheme.

(2) Since the final determination is made, the applicant of the ultimately selected application document should automatically transfer all copyrights (including but not limited to property rights of copyright, neighboring rights, and derivative product development rights), patent rights (including but not limited to design patent application rights), trademark rights (including but not limited to registered trademark application rights) and all other intellectual property rights and rights related to intellectual property, ownership and all derivative - 10 -

rights that can be obtained and enjoyed globally and are not prohibited from transfer by applicable laws in terms of the ultimately selected application document to Chengdu ExCo (including other third parties recognized by Chengdu ExCo) free of charge in an permanent manner. The applicant of the ultimately selected scheme undertakes not to exercise and authorizes Chengdu ExCo (including other third parties recognized by Chengdu ExCo) to permanently and exclusively exercise the moral rights related to the selected scheme worldwide to the extent permitted by applicable laws.

(3) If the submitted application document involves copying, plagiarism or any infringement of lawful rights and interests (including but not limited to infringement of third-party copyrights) of any third party, Chengdu ExCo and the organizer of the Solicitation appointed by Chengdu ExCo will bear no liability. Any legal liability arising therefrom shall be borne by the applicant only. Chengdu ExCo reserves the right to recover any losses incurred therefrom from the applicant.

(4) If any dispute and controversy arising from the Solicitation fails to be resolved through friendly negotiation, it should be submitted to the Chengdu Arbitration Commission for arbitration.

Before submitting the application documents, the applicant must carefully read, fully understand and agree to the aforementioned terms and conditions. If the applicant submits the application documents, it will be deemed that the applicant fully agrees all content of the Solicitation Document. Chengdu ExCo has the final interpretation right of the Solicitation.

## Letter of Commitment

The Executive Committee of The World Games 2025 Chengdu (hereinafter referred to as the "Chengdu ExCo"),

The legal person/unincorporated organization/natural person (hereinafter referred to as the "Promisor"), on the premise of being fully aware of and voluntarily accepting the requirements specified in the *Solicitation Document for the Appearance Design Solicitation for TWG 2025 Chengdu Torch* (hereinafter referred to as the "Solicitation") and all appendixes thereof, hereby make the following commitments to Chengdu ExCo:

Article 1 By signing the *Letter of Commitment*, the Promisor hereby agrees to voluntarily participate in the Solicitation as an applicant, comply with all requirements stipulated for the Solicitation, and submit all required application documents.

Article 2 The Promisor hereby voluntarily makes the following warranties and commitments concerning the participation in the Solicitation to Chengdu ExCo and its relevant affiliates:

1. The Promisor (including but not limited to the Promisor's members, employees, consultants, agents and/or any third parties working for the Promisor, hereinafter referred to as the "Promisor's Personnel") has read in detail and understood the *Appearance Design Solicitation Document for TWG 2025 Chengdu Torch* and all of its appendixes (hereinafter referred to as the "Solicitation Document"), and promises to comply with the relevant arrangements and requirements (including but not limited to those set out in the Solicitation Documents) made and to be made by Chengdu ExCo for the Solicitation without any objection.

2. The Promisor and all Promisor's Personnel and relatives will not disclose any confidential information about Chengdu ExCo or TWG 2025 Chengdu that they have learned during the Solicitation to any third party.

3. The Promisor and all Promisor's Personnel and relatives will neither conduct commercial promotion of the Promisor's participation in the Solicitation at any time, in any place and in any manner, nor explicitly or implicitly indicate any association between the Promisor and Chengdu ExCo, TWG 2025 Chengdu and other affiliates. The Promisor will not use or authorize the use of any TWG property, including but not limited to logo, emblem, trademarks, themes, signage, mascots, and torch-related elements or other designations without the written consent of Chengdu ExCo.

4. All costs and expenses incurred by participating in the Solicitation will be borne by the Promisor unless otherwise agreed with Chengdu ExCo.

5. The Promisor has the civil rights and capacity for civil conduct to participate in the Solicitation (statutory agent's consent is required if the Promisor has no or limited capacity for civil conduct, and any documents submitted to Chengdu ExCo should be signed by both the Promisor and the statutory agent). Any and all seals and signatures, and documents submitted by the Promisor during the Solicitation will be true, legal and valid, as well as binding on the Promisor.

6. The Promisor respects any and all evaluation opinions and decisions made by the Evaluation Panel of the Solicitation and Chengdu ExCo on the application documents.

7. The Promisor undertakes not to disparage TWG 2025 Chengdu and Chengdu ExCo in any way. The Promisor will always respect the dignity and honor of Chengdu ExCo and will not take any action that may be detrimental to the rights, image, reputation or honor of TWG 2025 Chengdu and Chengdu ExCo.

Article 3 The Promisor hereby voluntarily makes the following warranties and commitments concerning the use, transfer and ownership of the intellectual property rights, and other rights and interests in the application documents to Chengdu ExCo and its relevant affiliates:

1. The Promisor warrants the originality of the design scheme submitted to Chengdu ExCo (including any schemes submitted at any time under any circumstances such as initial submission, subsequent modification, supplementation, improvement or re-submission after withdrawal, including but not limited to the art work of the torch image, the torch name, the design description text, the complete work/name as mentioned above, and any elements or components of the work/name), and warrants that the design scheme is completed by the Promisor on his/her own without the assistance of any other person, and that there is no infringement, breach of contract, or any other violation of law or misconduct in the design scheme and its use by Chengdu ExCo (including third parties recognized by Chengdu ExCo).

2. The Promisor understands and agrees that if the application document submitted by the Promisor is selected as a candidate scheme or the ultimately selected scheme, the Promisor should comply with the following agreements:

(1) If the application document is selected as a candidate scheme, the Promisor should sign the relevant legal documents with Chengdu ExCo according to the time and place specified in the notice sent by Chengdu ExCo within 10 days upon receipt of such notice, agree to make appropriate modifications and improvements to the application document on his/her own or by authorizing Chengdu ExCo to do so if necessary, and agree on issues such as the relevant intellectual property rights in the application document. If the Promisor explicitly refuses to sign the above documents, it will be deemed that the Promisor has automatically given up his/her candidacy. In such case, Chengdu ExCo should no longer consider the application document of such applicant as a candidate scheme.

(2) Since the final determination is made, the Promisor should automatically transfer all copyrights (including but not limited to property rights of copyright, neighboring rights, and derivative product development rights), patent rights (including but not limited to design patent application rights), trademark rights (including but not limited to registered trademark application rights) and all other intellectual property rights and rights related to intellectual property, ownership and all derivative rights that can be obtained and enjoyed globally and are not prohibited from transfer by applicable laws in terms of the ultimately selected application document to Chengdu ExCo (including other third parties recognized by Chengdu ExCo) free of charge in an permanent manner. The Promisor undertakes not to exercise and authorizes Chengdu ExCo (including other third parties recognized by Chengdu ExCo) to permanently and exclusively exercise the moral rights related to the selected scheme worldwide to the extent permitted by applicable laws.

3. The Promisor warrants that it has neither disclosed, published, used or developed the design scheme globally in any form, nor authorized any third party to do so prior to submission to Chengdu ExCo; and that it should neither disclose, publish, use or develop the design scheme globally in any form, nor authorize any third party to do so after submission to Chengdu ExCo and before the end of the Solicitation and it is determined that the design scheme has not been selected as a candidate scheme.

4. The Promisor understands and agrees that Chengdu ExCo has the right to use any and all of the application documents submitted by the Promisor free of charge for the Solicitation and the evaluation of the design of TWG 2025 Chengdu Torch, including but not limited to filming, recording, publishing, broadcasting and other activities recording the working process and promoting the Torch.

5. The Promisor agrees that, in consideration of the nature of the Solicitation and TWG 2025 Chengdu, Chengdu ExCo is not supposed to pay any transfer fee or any royalty or other fees related to the commercial or other forms of utilization of the application document to the Promisor (including the Promisor, other third parties acting on behalf of the Promisor, and any other third party claiming that the Promisor has committed an infringement or violation of the law). The Promisor undertakes that it will not claim a share in the profits, income or any other proceeds arising from the commercial utilization of the design scheme in any form and identity or under any name.

6.
